ACQUISITION OF LANDS

[G.O. Ms. No. 127, Planning, Development and Special Initiatives (S.I), 26th September 2012, Purattasi 10, Thiruvalluvar Aandu-2043.]

No. II(2)/PDSI/628(a)/2012.

Whereas it appears to the Government of Tamil Nadu that the lands specified in the Schedule below and situated in St. Thomas Mount (Contonment), Alandur Taluk, Kancheepuram District are needed for a public purpose to wit, for the purpose of formation of Ashok Nagar to St. Thomas Mount Track for Chennai Metro Rail Project, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of the Section 4 of the Land Acquisition Act 1894 (Central Act I of 1894) and whereas, it has become necessary to acquire the immediate possession of the lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provisions of Section (1) of the Section 17 of of the said Act.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of the Tamil Nadu hereby authorizes the Special Tahsildar Land Acquisition Kancheepuram Unit, Chennai Metro Rail Project, No. 7, Conron Smith Road, Harini Towers, 2nd Floor, Gopalapuram, Chennai-86 and his staff and workman to excise the powers conferred by the said sub-section.

Under sub-section 3(c) of the Act, the Governor of Tamil Nadu hereby appoints the Special Tahsildar Land Acquisition Kancheepuram Unit, Chennai Metro Rail Project, No. 7, Conron Smith Road, Harini Towers, 2nd Floor, Gopalapuram, Chennai-86 to perform the functions of the Collector under the said Act.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of Section 5A of the said Act, shall not apply in this case.
