**Note:-**

1. The quoted rates shall not be less than the minimum wage notified by the Government of Tamil Nadu under the “Minimum Wages Act, 1948” and shall include all statutory obligations as applicable.
2. L1 (Lowest Bidder) will be decided on the Combined value of Service Charges of cost of Man power (A) and Cost of Equipments (B).
3. The Service Charges and lump sum equipment charges quoted will remain same for the entire period of contract even after extension if any.
4. Service Tax as applicable shall be borne by CMRL.
5. Any statutory variation in wages, VDA including Service Tax shall be borne by CMRL.
6. The requirement may increase/ decrease in any/ all the categories.
7. The total quantity variation shall not exceed Forty percent (40%).
8. No overwriting or cutting is permitted in the Financial Bid Form. In such cases, the tender shall be summarily rejected. However, the cuttings, if any, in the Technical Bid must be initialled by the person authorized to sign the tender bids.
9. The Equipment charges will be paid as per actual usage and as per agreed rate “per day” in the Finance bid.
