Chennai Metro Rail Limited (CMRL), a Joint Venture of Government of India and Government of Tamil Nadu, is a special purpose vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Chennai.

- (i) Age, qualification & experience stipulated for above posts should be as on <u>03-01-2024</u>. Age will be relaxed for deserving and experienced candidates.
- (ii) Higher remuneration / Higher post shall be considered based on the past experience, performance in the interview, higher qualification, exceptional credentials and expertise in the relevant field.

1) Required Qualification and Experience: -

a) <u>General Manager / Additional General Manager (Elevated construction) (02 Post) – Post Code – 1</u>

Must be a B.E / B. Tech (Civil) graduate from a Govt. recognized University / Institute, approved by AICTE / UGC. M.E / M. Tech Graduate (Civil / Structural Engineering) is preferable. The candidate should possess minimum years of post qualification experience (17 yrs for AGM & 20 yrs for GM) in execution of large Infrastructure projects like Major Bridge Constructions with

Highways / Railways and Metro Rail Project. Should be familiar with contract management related to large infrastructure projects. Should have knowledge & skill in management of FIDIC conditions of contract / International civil construction contracts.

Exposure in Quality Control & Assurance system in civil construction, Safety Implementation, Program Monitoring, IS / International Codes for construction of civil Elevated structures will be an added advantage.

b) General Manager / Additional General Manager (Underground construction) (02 Post) – Post Code – 2

Must be a B. E / B. Tech (Civil) graduate from a Govt. recognized University / Institute, approved by AICTE / UGC. M.E / M. Tech Graduate (Civil / Structural Engineering) is preferable. The candidate should possess a minimum of years of post-qualification experience (17 yrs for AGM & 20 yrs for GM) in execution of large Infrastructure projects like Under Ground Tunnel having experience as mentioned below.

- i. Out of the total years of experience, 5-8 years experience exclusively in Under Ground metro construction either in Tunnel (TBM) or UG station works is essential.
- ii. Should have experience in diaphragm wall construction work/ deep excavation work / mass concrete for base slab and roof slab work and heavy structural work for station construction.
- iii. Should be familiar with Contract Management / FIDIC contracts and International civil construction contracts.
- iv. Should have good exposure in QA / QC systems and Safety monitoring systems.
- v. Should have good coordination skill to liase with other stakeholders.
- vi. Ensure timely achievement of project targets, strategic inputs and decisions for speedy resolution of issues.
- vii. Monitor General Consultant & Contractor's performance.
- viii. Should maintain and ensure good coordination with Government agencies for facilitation of approvals.
- ix. Appraise inter-departmental coordination issues to management.

c) <u>Deputy General Manager (Architect) (01 Post) – Post Code – 3: -</u>

Must be a B. Arch graduate from a Govt. recognized Institute / University approved by AICTE / UGC.

The incumbent should have minimum 13 years of post qualification experience in Architecture design for a large infrastructure project preferably in Metro Rail Projects/Railway. The incumbent should also be familiar with design aspects of life safety and fire safety requirement in design implementations and material selection. Knowledge in NBC & NFPA 130 & 101 is essential.

Experience shall be in design / construction of various elements of Architectural finishes for room layout and station signages are essential. Exposure in use of the design software like CADD, Revit is Mandatory and Photoshop, 3D Max, Equivalent software etc is preferrable.

d) Deputy General Manager (Design) - (01 Posts) - Post code 4: -

Must be a B. E / B. Tech (Civil) graduate from a recognized University / Institute, approved by AICTE / UGC. Possession of M. E / M. Tech degree (Civil / Structural Engineering) is preferable.

The candidate should have minimum 13 years of post-qualification experience in planning and design of Viaducts, Bridges and Multi-storied Buildings. Out of 13 years of experience, minimum 08 years experience in Metro Railway projects with Design of Viaduct, Elevated Stations, Tunnels & Under Ground Stations is essential. Hands on knowledge of various computer applications, relating to the job and well versed with various design software's would be preferred.

The candidates should be familiar with the Standard Indian & Euro Codes and Practices followed in India for Buildings, Bridges, Tunnels and UG stations.

e) Manager (Architect) – (01 Post) – Post Code 5: -

Must be a B.Arch. graduate from a Govt. recognized University / Institute, approved by AICTE /UGC.

The incumbent should have a minimum of 7 years post qualification experience in Architecture design for a large infrastructure project preferably in Metro Rail Projects/Railway. The incumbent should also be familiar with design aspects of life safety and fire safety requirement in design implementations and material selection. Knowledge in NBC & NFPA 130 & 101 is essential.

Experience shall be in design / construction of various elements of Architectural finishes for room layout and station signages are essential. Exposure in use of the design software like CADD, Revit is Mandatory and Photoshop, 3D Max, Equivalent software etc., is preferrable.

2) Selection process:

The selection methodology comprises of two - stage process, interview followed by a medical examination. The selection process will judge the candidate on different facets like knowledge, skills, comprehension, attitude, aptitude, and physical fitness.

Medical Examination:

Expenses for the first-time medical examination of the candidate will be borne by CMRL. However, in case a candidate seeks extension for joining, then the second time medical examination expenditure will be borne by the candidate. To & fro travel expenses for the medical test shall be borne by the candidate. The candidate who fails the prescribed medical test will not be given any alternative employment and the decision of CMRL is final on this issue.

3) Character & Antecedents:

The success in the above stated selection process does not confer any right to appointment unless CMRL is satisfied after such an inquiry, as may be considered necessary, that the candidate's character and antecedents is suitable in all respects for appointment to the service.

4) Concessions & Relaxations:

a. The age limit prescribed shall be increased by five years in respect of candidates belonging to Scheduled Castes or Scheduled Caste (Arunthathiyars) or Scheduled Tribes and two years in respect of candidates belonging to Most Backward Classes/ Denotified Communities, Backward Classes (other than Muslim) or Backward Classes (Muslim).

- b. A Differently Abled Person shall be eligible for an age concession up to ten years over and above the age limits prescribed for the notified post by direct recruitment only, provided the applicant is otherwise fully suitable and the disability is not such as would render him incapable of efficiently discharging the duties w.r.t post for which the candidate is selected.
- c. The upper age for Ex-Servicemen will be prescribed age limit plus the length of service in armed forces plus 03 years.

- c. Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility and time limit before paying the application fee.

6) General Conditions:

- a. Only Indian Nationals need apply.
- b. Age, Qualification & experience stipulated above should be as on <u>03-01-2024</u>. The candidates before applying are advised to ensure that they fulfill the eligibility criteria and other requirements mentioned and that the particulars furnished by them are correct in all aspects. In case, if it is detected at any stage of recruitment process that the candidate does not fulfill the eligibility criteria and / or does not comply with other requirements of this advertisement and / or the candidate has furnished any incorrect or false information or has suppressed any material fact, the candidature is liable to be rejected.
