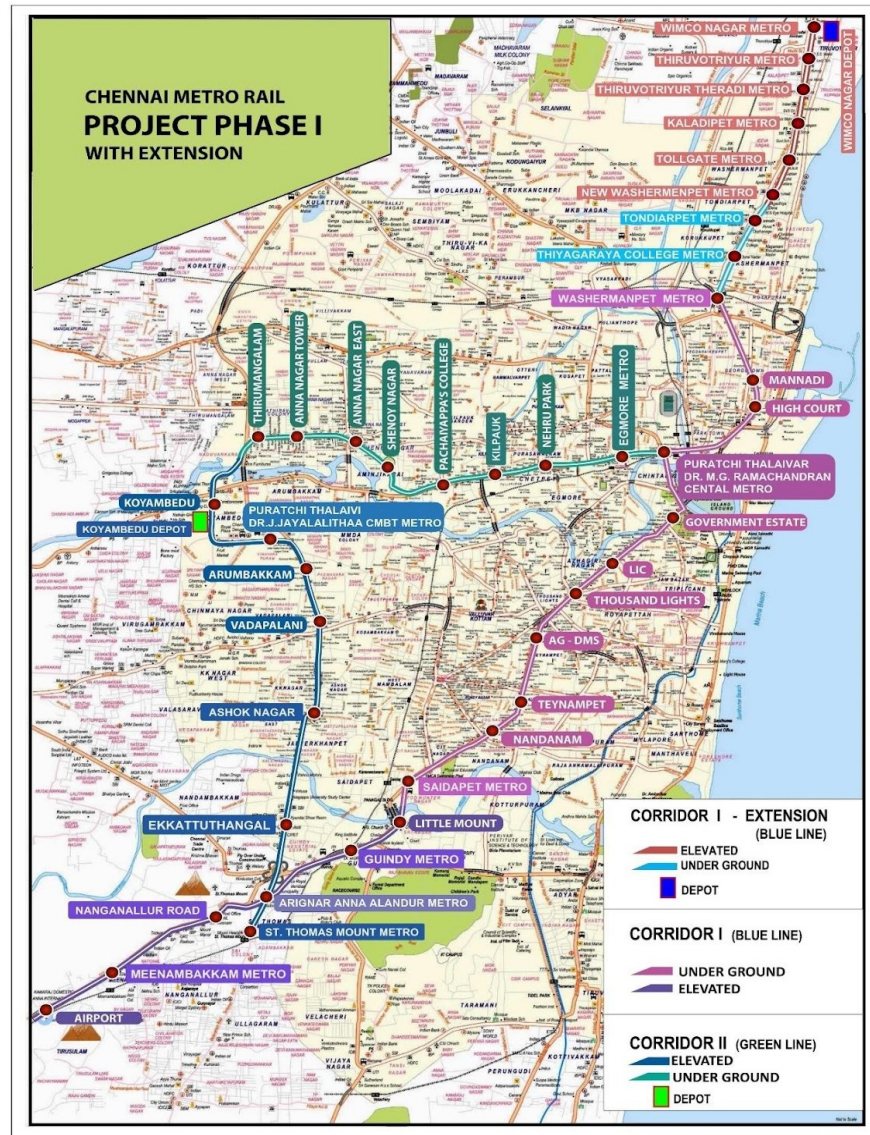

2. Introduction

2.1 About CMRL & Project

Chennai Metro Rail Limited (CMRL) is a joint venture of the Government of India (GoI) and the Government of Tamil Nadu (GoTN) for the construction of Phase 1 network in the Chennai city with loan assistance

from Japan International Co-operation Agency (JICA). The Phase I network is covering a total length of 54.1 km and consisting of two corridors (i.e. Corridor 1 from Wimco Nagar to Airport and the Corridor 2 from Chennai Central to St. Thomas Mount). There are 41 stations of which 21 are underground and 20 elevated. It is to be noted



that the entire Phase-I (i.e. 54.1 km) is fully operational, since February 2021. At present, the average daily ridership for the Chennai Metro Rail Phase I network is around 2.0 lakhs. CMRL has decided to enhance the ridership further through implementation of various schemes/strategies and to achieve optimum utilisation of its system.

2.2 Objective:

- To identify ways and means of ridership enhancement measures for Chennai Metro Rail Phase 1 Network (54.1km)
- To make it self-sustained Transit System through implementation of various strategic schemes/ activities

3. Eligibility Criteria

- i. The Firm should be registered firm having either single status or Joint venture.
- ii. The Firm should have at least five years' experience in carrying out Urban Transit system planning along with marketing of services which includes City Bus services related studies in National or International Scenarios.
- iii. The Firm should be registered under companies Act,1956 with annual average turnover of Rs. 1.0 Crores during last four years
