Chennai Metro Rail Limited (CMRL) invites quotations for above subject having following details: -

1. <u>Scope of Work</u>:

The scope of consultant involves: -

I. Assessment of software quality at CMRL contractor M/s ALSTOM premises at Bengaluru, based on below listed applicable standards.

ISO 25010: - System and software Quality requirements and Evaluation (SQuaRE) Functional suitability of software.

EN 50128 Railway applications - Communication, signaling, and processing systems — Software for railway control and protection systems".

ISO 9000-3: is a guidance document that helps software development organizations create quality assurance systems that comply with ISO standards. It's a guideline for applying the ISO 9001 standard to software development, supply, and maintenance.

II. To conduct 2 stage audits first preliminary and then assessment audit. Post Assessment detailed Report submission.

2. <u>Project timeline:</u>

The tentative dates for conducting the assessment audit are scheduled from April 2024 to June 2024. The sequential activities for the project include:

- II. Assessment at location
- III. Submission of Report

3. Similar work experience: -

- Vendors participating in the aforementioned work shall have been accredited as an inspection body in accordance with EN 17020 for signalling, functional safety and control system and also been accredited according to ISO 9001:2015.
- Experience of conducting software quality audits/assements according to EN 50128/ EN 50657 in at least 3 projects for railways/metros industry. Details shall be filled in Annexure-A and proof shall be attached here.

• Similar works means: -

Experience in conducting s/w quality audits, particularly in the railway industry for the railway systems. E.g. TCMS of Rolling stock, CBTC of signaling, ISA for signaling projects and products.

If bidder fails to submit the above similar works details, bid will not be considered for further evaluation.

5. <u>Payment terms:-</u>

- a. All the claims shall be approved by the competent official of CMRL. The payment will be effected within 30 days of submission of claim after due deductions of all statutory payments, taxes, penalties and other applicable deductions. Mobilization advance shall not be paid to the contractor. Tax deduction at source shall be made by CMRL as per the provisions of the Statutes/acts of statutory bodies/local authorities etc., except when the contractor prior to release of payment submits valid and complete documents for tax exemption.
- b. 100% Payment shall be after completion of work and only certification by Competent official of CMRL regarding satisfactory performance and acceptance of the completed work on receipt of the following documents of the billed work / supplied items.
- i. PAN card number, Bank account details. Bank address, RTGS details and GST details of the Agency are to be forwarded along with the invoice.
- ii. Documentary evidence towards GST payment and GST shall be paid only after the same is reflected in the GSTR 2B.

6. Validity of Quotation:

Quotation shall remain valid for a period of **180 days** from the date of quotation submission.

7. <u>Agency details:</u>

The bidder has to fill in the vendor detail form enclosed with this Tender Document as <u>Annexure-B</u> and same shall be forwarded along with quotation.

8. Jurisdiction:
