1.1 Name of Work

1.1.1 Chennai Metro Rail Limited (CMRL) (A Joint Venture of Govt. of India and Govt. of Tamil Nadu) invites online tenders through e-procurement portal from Sound, Reputed and Experienced Banks and/or Non-Banking Financial Institutions through National Competitive Bidding (NCB) under Single Stage Two Envelope system cum E-Reverse Auction (i.e. Technical & Financial) with initial filter criteria from eligible applicants, who fulfil qualification criteria as stipulated in Evaluation and Qualification criteria, for the below service:
