Step 3 – Candidates are required to fill all details in each section and make sure to upload the requisite documents as per the specification, wherever applicable, in order to authenticate the details mentioned in the online application form.

Scrutiny of applications for short listing of candidates will be solely based on documents /certificates uploaded by the candidates at the time of registration / submission of application through ONLINE.
