# 1. INTRODUCTION

Tamil Nadu Infrastructure Development Board (TNIDB), Government of Tamil Nadu (GoTN) has identified sixteen Depots/Terminus across Chennai for Modernization including Commercial Development. As part of this initiative, Chennai Metro Asset Management Limited (CMAML), an SPV formed between Chennai Metro Rail Limited (CMRL) and Tamil Nadu Infrastructure Development Corporation (TIDCO), has envisaged redevelopment of the existing Bus Depot at KK Nagar. The bus Depot, spanning across approximately 6 acres, is Operated and Maintained by the Metropolitan Transport Corporation (Chennai) Limited (MTC). The preparation of the Detailed Project Report (DPR) for the proposed project is currently underway. The project aims to Modernize the KK Nagar Bus Depot cum Terminal facilities for improved passenger experience and operational efficiency. CMAML envisions the development of State-of-the-Art Terminal and Depot facilities (for 400 buses) with enhanced commuter flow, circulation and overall functionality including modern passenger amenities.

# 2. INSTRUCTIONS TO FIRMS/APPLICANTS

Interested firms should provide information demonstrating the required qualifications and relevant experience to perform the works related to the specialized services required for the envisaged High capacity Automated Bus-Lift System. Firms meeting the Minimum qualification Criteria with respect to experience in similar projects and ability to provide services as per the Minimum Technical specifications as listed in section 2.2, will be invited to Present their respective capability / profile and tentative proposal.

#### 2.1 Submission Guidelines

### 2.1.1 Preparation of EOI Application

Prospective firms are requested to carefully peruse the contents of this EOI notification and prepare their EOI application in terms of the provisions/stipulations as made in this EOI notification.

# 2.2 Minimum features expected in the system (form iv)

As a minimum requirement, the Bus-Lift System should have the following features:

- 1. Design should be in compliance with The Lifts & Escalators Rules 1997, and other prevalent rules pertaining to installation and operational safety of the system
- 2. The Design should ensure minimum cost for the Operations and Maintenance of the Lift System and Maximum Life Cycle for the asset.

#### 2.3 Annual Maintenance Services

It is intended to carry out the Annual maintenance services (AMC) through the service provider, who design supply the system. The AMC shall remain valid for the lifetime of the bus lift system(s) covered under this agreement or until the system is decommissioned or replaced. The lifetime of the system shall be defined as the period during which the system is operationally viable as determined by industry standards, manufacturer specifications, and mutual agreement

The service provider shall provide comprehensive annual maintenance services for the high capacity bus lint system(s) installed at the proposed site. This includes, but is not limited to:

- Routine inspections and preventive maintenance.
- Prompt rectification of breakdowns or malfunctions.
- Replacement or repair of defective parts (as per terms mentioned in the tender document and agreed on thereafter)
- Ensuring compliance with all safety standards and statutory regulations.

#### 2.4 Technical Presentation

As part of EOI application, the firm shall submit the technical presentation as detialed n Form IV. If called for a presentation, the firms shall make their presentation through online/ offline mode.
