| 2     | 60      | Taking or causing to take offensive material upon metro railway   | Penalty up to Rs.2,500/- + shall be responsible for any loss or injury or damage to Metro Railway                         |
| 3     | 61      | Taking or causing to take dangerous material upon metro railway   | Imprisonment up to 4 years + Fine up Rs.5,000/- + shall be responsible for any Loss or injury or damage to Metro Railway. |
| 4     | 62      | Demonstration of any kind upon Metro Railway (Premises)/ Pasting posters, writing or drawing anything in the compartment or carriage (premises)/For refusal to Leave. | Penalty up to Rs.10,000/-   |
| 5     | 63      | Travelling on roof etc. of a train  | Imprisonment for up to 1 month or Fine up Rs.5000/- or with both + removal from train.                                    |
| 6     | 64      | Unlawfully entering or remaining upon metro railway   | Penalty up to Rs.5,000/-  |

| 7     | 67      | Obstructing running of train or rolling stock etc.  | Imprisonment up to 4 years or Fine up Rs.5000/- or with both  |

| 9     | 69      | Travelling without proper pass or ticket or beyond authorized distance   | <p>1. Ordinary single fare for the distance travelled or ordinary single fare from the station from which the train originally started by.</p> <p>2. The excess charge and any difference of fare mentioned in sub-section (2), fails or refuses to pay the same on a demand being made therefore, any metro railway official authorized by the metro railway administration in this regard may apply to any Metropolitan Magistrate or judicial Magistrate of the first class, for the recovery of the sum payable as if it were a fine."</p> |
