6.	Bid submission fee (Non-refundable)	A non-refundable Bid Submission Fee of INR 32,000/- (Indian Rupees Thirty Two Thousand only) inclusive of GST shall paid in the form of a NEFT/RTGS transaction. Bidders shall upload the scanned copies of transaction receipts along with the online bid submission. Bidders shall indicate the tender number & Name of the bidder in the transaction receipt.

Bid security amount (EMD) & Validity	EMD Amount: The total bid security/EMD amount shall be equal to INR 21,39,000/- (Indian Rupees Twenty One Lakh Thirty Nine Thousand only), and it shall be in the form of NEFT/RTGS (or) e-BG from any scheduled Bank in India. Validity: In the case of EMD by e-BG, it shall be valid for 208 days from the last date of bid submission Bidders shall upload the scanned copies of transaction receipts along with the online bid submission, and Bidders shall indicate the tender number & Name of the bidder in the transaction receipt.
